DC Classes: All SENIORS can exempt from the final for the College Park portion of the grade of a course if the above criteria is met. Lone Star College does not have exemptions for their final exam for a course and you will be required to take the Lone Star College Exam.

Administrative Note: Administration may change the decision of the exemption for students based on extenuating circumstances. Assistant principals will review and make a recommendation to the Associate Principal of Curriculum and Instruction for approval.

AP Classes: All students (9-11), who take an AP exam, can earn an additional end of the year exemption, for each AP class if all other requirements listed above are met. UNDERCLASSMEN who do not choose to take the AP exam will be required to take the end of the year exam.

DC Classes: All students (9-11) can choose a dual credit class as one of their end of the year exemptions for the College Park portion of the grade of a course if the above criteria are met. Lone Star College does not have exemptions for their final exam for a course and you will be required to take the Lone Star College Exam.

Administrative Note: Administration may change the decision of the exemption for students based on extenuating circumstances. Assistant principals will review and make a recommendation to the Associate Principal of Curriculum and Instruction for approval.
